Summary:

Detectives initiated at traffic stop at the intersection of Ross Rd and Raines Rd on a Nissan Sentra with TN Tag BJJ2458 that was driving at a high rate of speed traveling W/B on Raines Rd. While detectives were attempting to detain the driver he then started to resist with Detectives. The suspect was given loud verbal commands to stop resisting but continued to ignore detectives and attempted to grab detective Martin's duty weapon and was taken to the ground. The Suspect was still resisting and still continued to ignore the detective's verbal commands. The suspect then was sprayed with chemical agent by Detective Haley, but still

continued to resist. The suspect was able to stand back up and started fighting with me before he started to fight with Detective Martin while still ignoring the verbal commands. At that point I pulled out my city issued taser and pointed both the red lasers on the suspect's left upper torso and pulled the trigger to deploy the taser once. The taser had no effect on the suspect, and he then ran on foot S/B Ross Rd when I lost sight of him.

Summary:

Detectives were in the area of Riverdale/Winchester Ave when detectives observed a Blue Nissan Sentra driving reckless (in and out lanes without using turn signals at a high rate of speed). The Blue Nissan Sentra continued to drive recklessly (driving into oncoming traffic W/B on E Raines Rd). Detectives conducted a traffic stop where the vehicle came to a rest at E Raines Rd/Ross Rd. Detectives made contact with driver (Tyre Nicholas) and gave suspect Nicholas multiple directives to step out the car. Suspect Nicholas ignored all directives. Detectives used soft hands in effort to remove suspect Nicholas from the vehicle for detectives safety. As detectives were removing suspect Nicholas from the car suspect Nicholas snatched away and swinging his arms while stating " Why yall fucking with me"? Detectives tried to restrain suspect for a 2nd time, but suspect Nicholas ignored all directives and at that point suspect Nicholas was seen grabbing detectives Martin duty weapon while detective Martin stated, "Let my Gun Go". Suspect Nicholas was then taken to the ground and detective Haley deployed chemical agent. Detective Haley got up from the ground due to the chemical agent striking detective Haley in his right eye. Detectives Martin and Hemphill continued to try to get suspect Nicholas restrain but was unsuccessful. Suspect Nicholas continued to fight detectives. Detective Haley next saw suspect Nicholas running S/B on Ross Rd. Detective Haley tried to give chase, but the chemical agent prevented detective Haley from seeing.

Summary:

On 1/07/23, Detective E. Martin 13985 observed a blue 2017 Nissan Sentra baring TN BJN2458 driving recklessly at a high rate of speed at the Intersection of Riverdale/Winchester, jumping from lane to lane with without using the proper signal. Detectives observed the Nissan going w/b on Raines Rd, swerving into oncoming e/b traffic. Detective E. Martin conducted a traffic stop at E Raines/Ross Rd. Detectives made contact with the driver, Tyre Nichols. Detectives gave verbal commands to exit the vehicle. Tyre Nichols refused to get out of the vehicle after verbal commands were given. Detectives had to use soft hands to remove Tyre from the vehicle. While detaining Tyre, He began actively resisting detectives by snatching and swinging. Detectives gave verbal commands for him to stop resisting. While detectives were giving command to stop resisting, Tyre Nicols grabbed Detective E. Martin's duty weapon, attempting to take it out of the holster. Detectives used hard hands to prevent suspect Tyre Nichols from taking Detectives Martin's duty weapon, but that was unsuccessful. While still trying to get suspect Tyre into custody, he was still actively resisting by yanking, swinging, and swinging at detectives. Detectives gave verbal commands, but Tyre refused. Detectives Haley deployed his chemical agent, but it was unsuccessful. Once detectives saw that chemical agent was unsuccessful, Detective Hemphill, deployed his taser, but that as unsuccessful as well. Suspect Tyre Nicols then fled on foot, s/b on Ross Rd. Detectives were able to locate Tyre on Bear Creek Lane, still giving foot pursuit. Detectives attempted to detain Tyre, but he again became actively resistant. Detectives were able to get into custody.

Summary:

On 01/07/2023 Detective T. Bean (14711) with Scorpion Team 1 responded to a call for help at Ross Rd/ E Raines Rd where an individual fled from the scene from officers after resisting being detained despite taser and chemical agent being deployed. Detectives T. Bean and D. Mills observed a Male/Black with a camouflage Hoodie in hand fitting the description given by Detectives near Castlegate and Bearcreek. Detective T.Bean and D. Mills then observed the male/black actively wiping something off his face. Detectives then attempted to speak with the male black fled from Detectives on foot. Detectives were able to apprehend the suspect at Castlegate/ BearCreek in which the Suspect Tyre Nicholas actively resisted officers verbal and physical commands refusing to follow detectives commands. After struggling with the suspect Detective T.Bean utilized soft hands techniques with a closed hand which was not effective. The suspect continued to resist officers , in which additional officers made the scene to place the suspect into custody. Memphis Fire Department unit #28 and engine #55 made the scene for treatment Tyre Nichols was transported to St Francis Hospital.

Summary:

On 01/07/2023 Detectives J.Smith (13999) with Scorpion Team 1 answered a call for help at Ross Rd/ E Raines Road where individual active resisting officer and fled on foot from the scene. Detective J. Smith began checking the area and observed male black later identified as Tyre Nichols being taken to the ground by an officer. Suspect Tyre Nichols began actively resisting officers verbal and physical commands refusing to place his hands behind his back. After struggling with the above suspect, Detective J.Smith utilized soft hands technique with a closed hand which was not effective. Detective J. Smith then utilized his department issued chemical agent standing approximately 3 feet away into Tyre Nichols eyes which was still not effective, he continued to actively resist officers. Tyre Nichols was eventually place into custody after additional unit made the scene to assist. Memphis Fire Department unit #28 and engine #55 made the scene for treatment. Tyre Nichols was transport to St. Francis Hospital.

Officer Mills and Bean said "Hey" to Suspect Nichols and Suspect Nichols immediately began evading on foot. Officers Mills and Bean began to chase on foot. Officer Mills put out a broadcast of the location using Ross and Castlegate. Once Officer Mills caught up to Officers Bean and Smith, Officer Mills saw Suspect Nichols aggressively resisting Officer Bean and Smith. Officer Mills told Suspect Nichols that Officer Mills was going to spray him. Officer Mills deployed Chemical Agents. Suspect Nichols continued to resist Officers Bean and Smith aggressively. Once Officer Mills saw

that the Suspect Nichols continued to resist, Officer Mills used his baton and strike Suspect Nicholas on his right arm. Suspect Nichols still continued to resist after the baton strike. Suspect Nichols was eventually put into custody.
