RE: ORAL REPRIMAND ACCIDENT # 0212210412

On February 12, 2021 at 0412 hours, you were driving Unit 24 which was involved in an accident. You were driving Unit 24 out of the exit gate of to the hospital with non-critical patient in the rear along with You got out of the unit temporarily and moved the mirrors inward to navigate through the narrow exit and continue transporting the patient to the hospital. Your attempt to exercise caution was not successful and you did not find out that damage was caused to Unit 24 until later arriving at the hospital. The unit sustained scratches and minor damage to the passenger side. I personally went to the apartment complex and saw the broken and leaning exit gate. B/C Burns (B20B) conducted the accident investigation and forwarded all necessary reports. D/C Grant and B/C Burns both concluded that this accident did not warrant a post-accident test. You were not issued a citation from STIS Sgt. Ken Fox (IBM #0342). You are not currently under any progressive disciplinary action.

Based upon the facts presented above, you are charged with violating the following Division of Fire Services Operations Manual Rules:

Section: 101.03, Page 15, Number 4

Drive and operate apparatus safely, as dictated by street, road, weather, or other hazardous conditions and Divisional Regulations, State Laws, and Municipal Ordinances.

Section: 102.02, Page 8, Number 52

Members ... shall not neglect or fail to perform any portion of their duty as required by rule, regulation, order, common practice, or training.

Section: 103.01, Page 2, Number 11. H and I

- · Neglect of duty of negligence
- · Destruction of property

Section: 103.02, Page 1, Number 3

Division employees will operate all vehicles safely, as dictated by street road, weather, or other hazardous conditions and Divisional Regulations, State Laws, and Municipal Ordinances

An administrative investigation was conducted, and a hearing was held at Fire Station 53 on April 24, 2021 at 1200 hours. Present at this hearing were Presiding Officer BC Johnny B. Harrison, Jr. (B-10-A), BC Major McNeil (B-8-A) observer, Lieutenant Roderick Moore observer, and yourself. During the hearing, you acknowledged that you read and understood the charges that were filed against you. You were presented with the facts above, asked a series of questions, and allowed to explain what happen. You stated "We were in route to the hospital. The apartment complex was one way in and one way out. The exit gate was half open and the top of the gate was sort of slumped over. I got out and closed in the side mirrors to pass through the gate. The other option was to turn the unit around and go through the entry gate."

As a result of the investigation and the facts which are evident in this case, you must be aware of the problems created by your actions. Unit 24 was able to respond to emergency calls and did not have to be placed out of service for the investigation. However, you must obey all Division of Fire Services policies.

According to your personnel file, you are not currently under progressive disciplinary actions. Therefore, because of your actions and your violation of the above stated regulations, you will receive an **Oral Reprimand** which will go into your file for six (6) months, from April 28, 2021 until October 28, 2021. You will also be required to complete remedial Driver Training at Chester Anderson Training Center on duty to be scheduled by the Training Bureau.

I hope that you realize by this disciplinary action the seriousness of your actions. You must understand that future violations of this nature will result in more progressive disciplinary action being taken against you. Please know that the Memphis Fire Department and I are here to assist you in your professional development. Let me encourage you to seriously evaluate your current practices and seek not only to improve them but to share your knowledge with others you work with. If there is any way I may assist you in this endeavor, please contact me.

FIRE RECRUIT, FIRE PRIVATE II LATERAL, and FIREFIGHTER PARAMEDIC LATERAL EMT / AEMT / PARAMEDIC CERTIFICATION AND RECERTIFICATION AGREEMENT

I. INTRODUCTION

The City of Memphis Fire Services Division is committed to providing the highest quality of first aide, pre-hospital care, and emergency assistance to all citizens of Memphis. Therefore, it is the policy of the Fire Services Division to require the following of all Fire Suppression employees hired after January 1, 2015, based on their designation at hire.

II. EMPLOYMENT DESIGNATION AND COMPELTION REQUIREMENTS

Following are the hiring designations and related training and licensure requirements for Fire Recruit, Fire Private II Lateral and Firefighter Paramedic Lateral (hereinafter "Fire Recruit/Lateral Trainee").

I am to be hired for the position of Fire Fighter EMT, AEMT, and Paramedic. ______ initials

- 1. Fire Recruit/Lateral Trainee will be required to complete the coursework / testing and become licensed by the State of Tennessee as a Paramedic within the below listed timeframes from the date of employment based on their State of Tennessee emergency medical licensure level at the time of employment and must maintain their Paramedic license as a condition of continued employment, after attaining the step EMS license levels listed below where applicable.
- 2. Fire Recruit with no emergency medical license by the State of Tennessee or any other state must be licensed by the State of Tennessee as an Emergency Medical Technicians (EMT) within their first twelve (12) months of employment, as an Advanced Emergency Medical Technician (AEMT) within their first twenty-four (24) months of employment, and as a Paramedic within their first forty-eight (48) months of employment and must maintain such license as a condition of continued employment.
- 3. Fire Recruit/Lateral Trainee with an Emergency Medical Technician (EMT) license by the State of Tennessee must be licensed by the State of Tennessee as an Advanced Emergency Medical Technician (AEMT) within their first twelve (12) months of employment and as a Paramedic within their first thirty-six (36) months of employment and must maintain such license as a condition of continued employment.
- 4. Fire Recruit/Lateral Trainee with an out-of-state Emergency Medical Technician (EMT) or equivalent license who hold or have held a National Registry Emergency Medical Technician certification must be licensed by the State of Tennessee as an Emergency Medical Technician (EMT) within their first three (3) months of employment, as an Advanced Emergency Medical Technician (AEMT) within their first twenty-four (24) months of employment, and as a Paramedic within their first forty-eight (48) months of employment and must maintain such license as a condition of continued employment.
- 5. Fire Recruit/Lateral Trainee with an out-of-state Emergency Medical Technician (EMT) or equivalent license who never held a National Registry Emergency Medical Technician certification must be licensed by the State of Tennessee as an Emergency Medical Technician (EMT) within their first eight (8) months of employment, as an Advanced Emergency Medical Technician (AEMT) within their first twenty-four (24) months of employment, and as a Paramedic within their first forty-eight (48) months of employment and must maintain such license as a condition of continued employment.

FIRE RECRUIT, FIRE PRIVATE II LATERAL, and FIREFIGHTER PARAMEDIC LATERAL EMT / AEMT / PARAMEDIC CERTIFICATION AND RECERTIFICATION AGREEMENT

- Fire Recruit/Lateral Trainee with an Advanced Emergency Medical Technician by the State of Tennessee must be licensed by the State of Tennessee as a Paramedic within their first twenty-four (24) months of employment and must maintain such license as a condition of continued employment.
- 7. Fire Recruit/Lateral Trainee with an out-of-state Advanced Emergency Medical Technician or equivalent license who hold or have held a National Registry Advanced Emergency Medical Technician certification must be licensed by the State of Tennessee as an Advanced Emergency Medical Technician within their first three (3) months of employment and as a Paramedic within their first thirty-six (36) months of employment and maintain such license as a condition of continued employment.
- 8. Fire Recruit/Lateral Trainee with an out-of-state Advanced Emergency Medical Technician or equivalent license who never held a National Registry Advanced Emergency Medical Technician certification must be licensed by the State of Tennessee as an Advanced Emergency Medical Technician within their first eight (8) months of employment and as a Paramedic within their first thirty-six (36) months of employment and maintain such license as a condition of continued employment.
- 9. Fire Recruit/Lateral Trainee with a Paramedic license by the State of Tennessee must maintain such license as a condition of continued employment.
- 10. Fire Recruit/Lateral Trainee with an out-of-state Paramedic or equivalent license who hold or have held a National Registry Paramedic certification must be licensed by the State of Tennessee as a Paramedic within their first three (3) months of employment and maintain such license as a condition of continued employment.
- 11. Fire Recruit/Lateral Trainee with an out-of-state Paramedic or equivalent license who never held a National Registry Paramedic certification must be licensed by the State of Tennessee as a Paramedic within their first eight (8) months of employment and maintain such license as a condition of continued employment.

III. TESTING AND PROOF OF LICENSE REQUIREMENTS

Following are the testing deadlines for the purpose of obtaining applicable EMT, AEMT, and/or Paramedic licensing:

- Fire Recruit/Lateral Trainee must take the National Registry Written Examination ("NRW Examination") within thirty (30) calendar days after successfully completing the applicable EMT, AEMT, and/or Paramedic training programs.
- 2. Fire Recruit/Lateral Trainee with an out-of-state EMT, AEMT, Paramedic or equivalent license and no National Registry EMT, AEMT, and/or Paramedic certification must take the National Registry Written Examination ("NRW Examination") within thirty (30) calendar days after successfully completing the applicable EMT, AEMT, and/or Paramedic "National Registry Refresher Training for Candidate Testing" program through the Memphis Fire Department Emergency Medical Services Training Bureau.

FIRE RECRUIT, FIRE PRIVATE II LATERAL, and FIREFIGHTER PARAMEDIC LATERAL EMT / AEMT / PARAMEDIC CERTIFICATION AND RECERTIFICATION AGREEMENT

- 3. Additional attempts at passing the NRW Examination must be completed within thirty (30) calendar days of the previous attempt(s).
- 4. If a refresher course is mandated / required to sit for the NRW Examination after previous exam failure(s), then such refresher course must be completed within thirty (30) calendar days of the most recent date the employee took the exam. Thereafter, the employee must sit for the NRW Examination within thirty (30) calendar days of the mandated/required refresher course.

Following are the deadlines for the purpose establishing proof of licensure:

- Fire Recruit/Lateral Trainee must apply for State of Tennessee applicable EMT, AEMT, and/or Paramedic license within ten (10) calendar days of passing the National Registry Written Examination. (This includes application, background check and all applicable fees.)
- Fire Recruit/Lateral Trainee must submit proof of their State of Tennessee applicable EMT, AEMT, and/or Paramedic license to Fire Services Division Administration within ten (10) calendar days of receipt.

IV. LICENSE RENEWAL AND MAINTENANCE REQUIREMENT

- Fire Recruit/Lateral Trainee must maintain their applicable EMT, AEMT, and Paramedic license while employed with the Fire Services Division as a minimum requirement for continued employment.
- License renewal will be required every two (2) years as governed by the legal standards for EMT, AEMT, and Paramedic licensure within the State of Tennessee or as otherwise required by governing law.
- 3. Fire Recruit/Lateral Trainee must provide documentation of their emergency medical license and license renewal to their supervisor in accordance with Fire Services Division policy. Should the employee fail to achieve license renewal as required by the State of Tennessee, the employee shall notify his/her immediate supervisor, in writing, no later than the required two (2) year license renewal date.
- 4. Fire Recruit/Lateral Trainee must notify Fire Services Division Administration through their chain of command should any action be taken by the State of Tennessee against their emergency medical license (i.e. revoked, suspended, and/or probation).

V. GENERAL REQUIREMENTS

Fire Recruit/Lateral Trainee will attend EMT, AEMT, and Paramedic training on off duty days and will not be compensated for the training time.

- 1. The provisions outlined within this agreement are minimum standards for continued employment with the City of Memphis Fire Services Division.
- 2. Should the City of Memphis decide to change the above procedures for other Fire Recruit/Lateral Trainee classes, it reserves the right to require those hired under this agreement to maintain their emergency medical license. Should the City of Memphis decide not to continue the emergency medical licensure program for all Fire Fighter Recruit and Lateral employees, neither party shall be bound by the terms set out herein.

The City of Memphis Fire Services Division is committed to providing a quality level of fire service training for employees within the Division of Fire Services. The Memphis Fire Department therefore has adapted the NFPA 1001 Standard on Professional Fire Fighter Qualification effective January 1, 1991. Should mandated requirements by the state of Tennessee Commission on Fire Fighting for certification(s) be amended, this agreement shall be construed as being automatically amended in accordance therewith.

- Fire Private II Laterals and Firefighter Paramedic Laterals will be required to complete the coursework / testing and become certified as a Firefighter I and a Firefighter II by the Tennessee Commission on Fire Fighting within the below listed timeframe from the date of employment based on their Tennessee Commission on Fire Fighting level at the time of employment.
- Fire Private II Laterals and Firefighter Paramedic Laterals with an out-of-state Firefighter I or equivalent IFSAC and/or Pro Board accredited certificate must be certified by the Tennessee Commission on Fire Fighting as a Firefighter I within their first three (3) months of employment.
- 3. Fire Private II Laterals and Firefighter Paramedic Laterals with an out-of-state Firefighter II or equivalent IFSAC and/or Pro Board accredited certificate must be certified by the Tennessee Commission on Fire Fighting as a Firefighter II within their first tree (3) months of employment.
- Fire Private II Laterals and Firefighter Paramedic Laterals with an out-of-state Firefighter I or equivalent certificate without IFSAC and/or Pro Board accreditation must obtain Tennessee Commission on Fire Fighting Firefighter I certification within their first twelve (12) months of employment.
- 5. Fire Private II Laterals and Firefighter Paramedic Laterals with an out-of-state Firefighter I or equivalent certificate without IFSAC and/or Pro Board accreditation must obtain Tennessee Commission on Fire Fighting Hazardous Materials Awareness (HMA) certification within their first twelve (12) months of employment. (Tennessee Commission on Fire Fighting HMA certification is a prerequisite for Tennessee Commission on Fire Fighting Firefighter I Certification.)
- 6. Fire Private II Laterals and Firefighter Paramedic Laterals with an out-of-state Firefighter I or equivalent certificate without IFSAC and/or Pro Board accreditation must obtain Tennessee Commission on Fire Fighting Hazardous Materials Operations (HMO) certification within their first twelve (12) months of employment. (Tennessee Commission on Fire Fighting HMO certification is a prerequisite for Tennessee Commission on Fire Fighting Firefighter I Certification.)
- 7. Fire Private II Laterals and Firefighter Paramedic Laterals with an out-of-state Firefighter I or equivalent certificate without IFSAC and/or Pro Board accreditation must obtain Tennessee Commission on Fire Fighting Firefighter II certification within their first thirty-six (36) months of employment. (Tennessee Commission on Fire Fighting Firefighter I certification is a prerequisite for Tennessee Commission on Fire Fighting Firefighter II certification.)
