## AN ORDINANCE TO RENAME THE LINCOLN PARK PAVILION IN HONOR OF HAZEL MOORE AS THE HAZEL MOORE PAVILION IN THE CITY OF MEMPHIS

**WHEREAS**, on occasion, the Memphis City Council sees fit to recognize members of the Memphis community who have had a lasting impact and Hazel Moore is certainly worthy of recognition for her contributions, service, and dedication to improving the lives of individuals in the community of Memphis, Tennessee, throughout her illustrious career; and

**WHEREAS,** Hazel Moore has dedicated more than fifty (50) years to the field of cosmetology as a distinguished professional and licensed instructor, tirelessly sharing her expertise and passion with countless individuals; and

**WHEREAS,** Hazel Moore is a successful businesswoman and the esteemed sole proprietor of Hazel's Hair Fashion, a testament to her entrepreneurial spirit and commitment to excellence in the beauty industry; and

**WHEREAS,** Hazel Moore has been a trailblazer and influential figure in the beauty industry, setting high standards and paving the way for future generations of cosmetologists; and

**WHEREAS,** Hazel Moore has been appointed by three Governors of the State of Tennessee to serve on the State Board of Cosmetology, where she has played a crucial role in regulating state laws and ensuring the integrity of the profession; and

**WHEREAS,** Hazel Moore, driven by her commitment to community improvement and youth empowerment, founded a mentoring group for young ladies, providing scholarships and guidance to help them overcome challenges and achieve personal success; and

**WHEREAS**, under Section 12-84-22 of the City of Memphis Code of Ordinances states that when the city acquires any public parks or recreational areas, the Memphis City Council is responsible for naming them; the Council also has the authority to change the official names of existing parks and recreational areas through an ordinance; and

**WHEREAS**, the Memphis City Council now seeks to exercise its naming authority under Section 12-84-22 of the City of Memphis Code of Ordinances to rename the City of Memphis Lincoln Park Pavilion at 1594 S. Orleans Street in the city of Memphis, Tennessee in honor of Hazel Moore in recognition of her legacy and enduring impact on the Memphis community.

#### NOW, THEREFORE BE IT ORDAINED by the Council of the City of Memphis that:

Section 1. The City of Memphis Lincoln Park Pavilion at 1594 S. Orleans Street in the city of Memphis, Tennessee, and any replacement or successor facility, shall be renamed the "The Hazel Moore Pavilion."

Section 2. Upon passage of this ordinance, the newly named "The Hazel Moore Pavilion" shall be memorialized with a new facility sign and a suitable memorial plaque outside the clubhouse, acknowledging the honor. Any costs associated with the construction or installation of the sign shall be incurred by the City of Memphis Parks Division, and if necessary, the Memphis Parks Division shall bring a funding resolution before the City Council for consideration.

Section 3. The City of Memphis Parks Division shall make the appropriate arrangements to alter any media collateral and associated documentation to denote the name change to "The Hazel Moore Pavilion."

Section 4. Severability. All provisions of this Ordinance are hereby severable and if any of these sections, provisions, sentences, clauses, phrases, or parts are held unconstitutional or void, the remainder of this Ordinance shall continue in full force and effect.

Section 5. Effective Date. This Ordinance shall take effect from and after the date it shall have been passed by the Council, signed by the Chairman of the Council, certified and delivered to the Office of Mayor in writing by the comptroller and become effective as otherwise provided by law.

## Resolution Approving Use of Compounded Interest from Accelerate Memphis Bonds to cover shortfalls from Accelerate Memphis projects.

WHEREAS, on February 2, 2021, City Council approved an outline of projects for Accelerate Memphis, a \$200M bond issuance to make improvements to three categories: Activating Memphis 3.0, Revitalizing City Assets, and Improving Parks; and

WHEREAS, \$75,000,000.00 of said funding for Memphis Parks included an outline of projects for Memphis Parks; and

**WHEREAS**, the length of time needed to finish all projects allowed compounded interest, \$1,316,000, to accumulate in the accounts; and

WHEREAS, the time needed to complete projects also led to cost overruns and inflation; and

WHEREAS, City Council approved a list of projects to be completed; and

WHEREAS, in the spirit of that process, approval to allocate and appropriate those funds to Memphis Parks to complete projects led by Memphis Parks staff for improvements to parks, community and senior centers and pools; and

WHEREAS, once approved, the funds would be used to pay the costs associated with these projects.

**NOW, THEREFORE, BE IT RESOLVED,** by the Council of the City of Memphis that Memphis Parks is authorized to transfer \$1,316,000 of compounded interest from Accelerate Memphis projects to Fiscal Year 2024 CIP Project Number PK24103, to cover the costs associated with the following:

WHEREAS, Everybody Plays is a 501(c)(3) non-profit doing business as Miracle League of Memphis (the "Miracle League") whose mission is One Field. One Playground. Everybody Plays and,

WHEREAS, certain funders and supporters of Miracle League, and the City desire to transform and make improvements to Tobey Park Field #1; and

WHEREAS, Miracle League has agreed to fund raise and provide the cost of said renovation; and,

WHEREAS, Miracle League has agreed to management of the renovation project and to serve as a coordinator between the funders, architects, and Memphis Parks staff; and

WHEREAS, the City and Miracle League desire to memorialize their agreements herein.

**NOW THEREFORE,** for and in consideration of the premises herein, the receipt and sufficiency of which are hereby acknowledged, the undersigned agree as follows:

WHEREAS, the City of Memphis desires to enter a Use Agreement with Miracle League for the project management and subsequent non-exclusive use of built amenities with a term of 5 years with an option to extend for two (2) additional five (5) -year periods, subject to mutual agreement of the parties, evidenced in writing.

WHERAS, City of Memphis Ordinance No. 4763, Article 1, Section 23-1(d) requires the Council of the City of Memphis to approve all management and use agreements for Parks facilities; and

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Memphis that this Use Agreement between the City of Memphis and Miracle League, as agreed to by the parties, is hereby approved in accordance with the terms set forth therein outlining committed operational and other stipulated criteria as to both parties in the approved agreement.

Since 2020, Memphis Parks has been engaged with a local nonprofit Everybody Plays- Miracle League of Memphis. This group has a mission of bringing a fully accessible ballfield to Memphis. Memphis Parks worked with Miracle League to identify Tobey Park as the best fit location for this amenity. Miracle League has spent three years actively fundraising for this project and is now ready to begin construction. At this time, zero funds are required by the City.

Due to Miracle League's position as the lead funder and overall project manager, it is necessary that Memphis Parks enter an agreement with Miracle League to manage this construction project under the supervision of Memphis Parks.

#### 2. Executive Summary of Agreement Terms

- Use Agreement- covering both construction management period and non-exclusive use following completion of construction
- Term Length 5 year agreement with 2 options to extend 5 years
- Miracle League funds and manages construction with approval of every step by Memphis Parks
- City maintains ownership and all operations
- Upon completion of construction, Miracle League will not be charged permit fees for programs which are hosted by Miracle League; Memphis Parks will permit field to all other users and retain all revenue

# A Resolution to Approve Intergovernmental Agreement Between the City of Memphis and Shelby County Government for Animal Housing and Rabies Tag/Fee Collection

WHEREAS, the city, through the Memphis Animal Services department, operates the City Animals Shelter facility, which houses and cares for animals that must be impounded or otherwise maintained under state law, local animals control ordinances, and humane considerations; and

WHEREAS, the City has heretofore provided use of its City Animal Shelter facilities and professional staff to assist the County with the housing and care of animals both impounded by the County and surrendered by County residents from areas outside the City of Memphis, excluding the municipalities of Bartlett, Germantown, and Collierville, as these municipalities have their facilities;

WHEREAS, the County needs the continued provision of such services and the use of necessary facilities for the housing and care of animals that must be impounded and otherwise maintained per state law, local animal control ordinances, and humane considerations, as well as processing of rabies tags for residents of the County; and

WHEREAS, Tennessee law, codified at T.C.A. §12-9-101 et seq., and more specifically T.C.A. §12-9-108, provides that a public agency of the State may contract with another public agency to perform a governmental service which each public agency authorized by law to perform, provided said contract is approved by the governing body of each party; and

WHEREAS, the parties hereto are public agencies within the meaning of these laws; and

WHEREAS, Tennessee law, codified at T.C.A §68-8-105, and Shelby County Code of Ordinances, codified at §4-65, et seq., require all pet owners to vaccinate against rabies; and

WHEREAS, the County, according to Section 4.3 of the Shelby County Code of Ordinances, may enter into contracts for the care, housing, and disposal of animals; and

WHEREAS, the County, according to Section 4.3 of the Shelby County Code of Ordinances, may enter into contracts to provide animal sheltering services and rabies tag collections for the County, and the City agrees to do so on the terms and conditions set forth under the Agreement.

WHEREAS, this is an intergovernmental agreement that requires approval by the Memphis City Council according to T.C.A §12-9-108.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MEMPHIS**, the form, terms, and provisions of the Agreement between the City of Memphis and Shelby County Government for Animals Services presented to this Council is hereby approved, and all terms and provisions thereof.

**BE IT FURTHER RESOLVED**, that the City Council, acting on behalf of the City, hereby authorizes and approves the execution and delivery of the Agreement, and the Mayor of the City of Memphis, hereby is, authorized and directed to execute and deliver the Agreement in substantially the same form as presented to Council, with such changes, insertions, or omissions as may be deemed reasonably necessary by persons executing the same, upon advice of counsel, to accomplish the purpose of the transaction contemplated therein and in this Resolution and shall be inconsistent with or contrary to such purposes; and

**BE IT FURTHER RESOLVED**, that this Resolution shall become effective immediately upon adoption by the City Council.

A REFERENDUM ORDINANCE TO AMEND AND RESTATE ARTICLE 65, SECTIONS 667 AND 668 OF THE HOME RULE CHARTER OF THE CITY OF MEMPHIS, AS AMENDED, RELATIVE TO THE COMPOSITION OF THE BOARD OF COMMISSIONERS OF MEMPHIS LIGHT, GAS AND WATER DIVISION PURSUANT TO ARTICLE XI, § 9 OF THE CONSTITUTION OF THE STATE OF TENNESSEE (HOME RULE AMENDMENT)

**WHEREAS,** under Article 65, Section 667 of the City of Memphis Charter, the Memphis Light, Gas and Water Division Board of Commissioners ("Board of Commissioners") is comprised of 5 voting members; and

**WHEREAS**, under Article 65, Section 668 the City of Memphis Home Rule Charter, the members of the Board of Commissioners are appointed by the Mayor of Memphis, subject to approval by the Memphis City Council; and

WHEREAS, in 1983, members of the Board of Commissioners became required to live and reside in the City of Memphis pursuant to Home Rule Ordinance 3286, effective 1983, which stated in pertinent part "all member members of the various City of Memphis boards and commissions, excluding joint city-county boards and commissions, shall be required to live and maintain a residence within the limits of the City of Memphis": and

WHEREAS, Memphis Light, Gas and Water Division ("MLGW") provides electric, natural gas and water utility services to ratepayers within the boundaries of Shelby County, Tennessee with approximately one-third (1/3) of its ratepayers being located outside the boundaries of the City of Memphis; and

WHEREAS, it is in the best interest of the ratepayers for the Board of Commissioners to include representation of all the MLGW ratepayers; and

**WHEREAS,** a seven member Board of Commissioners, made up of five persons who live in the City of Memphis, and two members who reside outside of the boundaries of the City of Memphis, will provide for representation of all the ratepayers; and

WHEREAS, the MLGW Board of Commissioners recommends that the Board be comprised of seven (7) voting members, with at least 2 of the 7 members of the Board of Commissioners being residents outside of the boundaries of the City of Memphis, to be appointed by the Mayor of Memphis Appointment in consultation with the Mayor of Shelby County and the mayors of the suburban cities of Arlington, Bartlett, Collierville, Germantown, Lakeland, and Millington, and subject to approval by the Memphis City Council; and

WHEREAS, this amendment would not alter any authority held by the MLGW board of commissioners or the Memphis City Council; and

**WHEREAS**, it is deemed advisable to allow the citizens of Memphis to decide whether to amend the Charter and allow two additional voting members on the MLGW board of commissioners who reside outside of the city;

Section 1. Proposed Amendment and Authorization.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MEMPHIS, TENNESSEE, That pursuant to Article XI, Section 9 of the Constitution of the State of Tennessee, as amended, a proposal for amending the Charter of the City, as set forth in this ordinance, shall be published and submitted by the City of Memphis to its qualified voters at the first state general election, which shall be held in the City of Memphis on November 5, 2024, and which shall be held at least sixty (60) days after such publication.

BE IT FURTHER ORDAINED, That the proposed Charter Amendment of Article 65, Sections 667 and 668 shall read as follows:

The Memphis light, gas and water division shall consist of a board of Light, Gas and Water Commissioners composed of seven members. Five of the members shall be required to live and maintain a residence within the City of Memphis and two of the members shall be required to live and maintain a residence outside of the boundaries of the City of Memphis but within Shelby County. The Mayor shall consult with the mayors of the other incorporated municipalities in Shelby County prior to naming the appointees residing outside of the city limits. All Commissioners shall be appointed by the Mayor of the City of Memphis and shall be subject to approval by the Memphis City Council."

Section 2. Publication of Home Rule Amendment as required by Tennessee Constitution.

BE IT FURTHER ORDAINED, That the Comptroller is hereby directed to cause this Ordinance, as finally adopted, to be published pursuant to provisions of Article XI, Section 9 of the Constitution of the State of Tennessee immediately after adoption by the City Council.

<u>Section 3.</u> Certification and Delivery to Election Commission.

BE IT FURTHER ORDAINED, That upon the adoption of this Ordinance becoming effective as required by law, the Comptroller of the City of Memphis shall immediately certify adoption of this Ordinance and deliver a certified copy thereof to the Shelby County Election Commission in charge of holding the general state election on November 5, 2024, and shall request that the proposed amendment to the Home Rule Charter of the City of Memphis, in the preferred form set forth in this Ordinance, be placed on the ballot.

<u>Section 4.</u> Proposal and preference.

BE IT FURTHER ORDAINED, That the City Council does hereby adopt the suggested proposal and form of question to be placed on the ballot for a referendum vote on a Home Rule Amendment to the Charter of the City of Memphis in a State General election to be held on the 5<sup>th</sup> day of November, 2024, which question shall read as follows:

"Shall Article 65, Sec. 667 and 668 of the Home Rule Charter of the City of Memphis be amended to read as follows:

'The Memphis light, gas and water division shall consist of a board of Light, Gas and Water Commissioners composed of seven members. Five of the members shall be required to live and maintain a residence within the City of Memphis and two of the members shall be required to live

and maintain a residence outside of the boundaries of the City of Memphis but within Shelby County. The Mayor shall consult with the mayors of the other incorporated municipalities in Shelby County prior to naming the appointees residing outside of the city limits. All Commissioners shall be appointed by the Mayor of the City of Memphis and shall be subject to approval by the Memphis City Council.'?"

#### <u>Section 5.</u> Operative Date of Charter Amendment.

BE IT FURTHER ORDAINED, That the Charter Amendment proposed by this Ordinance shall take effect and become operative for the purposes set forth hereinafter sixty (60) days after approval by a majority of the qualified voters voting thereon in an election to be held the 5<sup>th</sup> day of November, 2024, the public welfare requiring it.

#### <u>Section 6.</u> Certification of Results.

BE IT FURTHER ORDAINED, That the Shelby County Election Commission certify the result of said election on the referendum question to the Comptroller of the City of Memphis, who shall see that said result is made a part of the Minutes of the Council of the City of Memphis.

#### Section 7.

BE IT FUTHER ORDAINED, That the Mayor be and hereby is authorized to appropriate and expend a sum sufficient to pay a pro-rata cost attributable to the inclusion of the proposed amendment on the ballot for the election to be held on the 5<sup>th</sup> day of November, 2024, if any;

#### Section 8. Nonconflicting – Conflicting law.

BE IT FURTHER ORDAINED, That from and after the effective date of this Home Rule Charter Amendment all laws constituting the present Charter of the City of Memphis in conflict with the subject matter of this mandatory Home Rule Charter Amendment shall be immediately annulled, vacated, and repealed and all laws constituting the present Charter of the City of Memphis not in conflict with the amendatory Home Rule Ordinance, be and the same here continued in full force and effect.

#### Section 9. Severability.

BE IT FURTHER ORDAINED, that is any clause, section, paragraph, sentence or part of this Ordinance shall be held or declared to be unconstitutional and void, it shall not effect the remaining parts of this Ordinance, it being hereby declared to be the legislative intent to have passed the remainder of this Ordinance notwithstanding the parts so held to be invalid, if any.

Section 10. Publication as required by the Charter.

BE IT FURTHER ORDAINED, that this Ordinance shall also by published by the Comptroller a the same time and manner as required by the City Charter for all ordinances adopted by the City Council.

Section 11. Enactment of Referendum Ordinance.

BE IT FURTHER ORDAINED, that the adoption of this Referendum Ordinance shall take effect from and after the date it shall have passed by the Council, signed by the Chair of the Council, certified and delivered to the Office of the Mayor in writing by the Comptroller, and become effective as otherwise provided by law.

A Resolution approving a 30-year Ground Lease, with Four (4) Ten-Year renewal options, for the construction and operation of a hotel on a designated site within The District @ Liberty Park with Capstone Development, LLC

Whereas, the City of Memphis must show the likelihood of Fifty Million Dollars of private development within the Liberty Park Tourism Development Zone to comply with the statutory requirements for tourism development zones as listed in Tennessee Code Annotated 7-88-101 et seq., as amended; and

Whereas, the presence of new private, commercial development within the Liberty Park Tourism Development Zone, and specifically the sales tax revenues generated by such private businesses, is essential to the City's ability to pay the annual debt service of approximately Three Million Seven Hundred Thousand Dollars (\$3,700,000) on the Tourism Development Zone Bonds issued to pay for the redevelopment of Liberty Park, and without such revenues, the City would be responsible for paying the annual debt service from its general fund; and

Whereas, the continued success of the Memphis Sports & Events Center ("MSEC") is enhanced significantly with the presence of nearby hotels and restaurants that cater to the youth and family demographics that attend multi-day competitions at MSEC, particularly since such amenities are increasingly available at other sports facilities with which MSEC must compete for business; and

Whereas, the City owns approximately 18 acres of real property within Liberty Park which is ideally situated for a mixed-use development (the "Master Development") that will include hotels, restaurants, food and beverage establishments, family entertainment venues, and niche retail to serve the visitors of MSEC and the Simmons Bank Liberty Stadium; and

Whereas, said property is depicted on Attachment A and is bordered by Central Avenue on the north, Fred Jones Way on the east, Raymond Skinner Avenue on the south, and Early Maxwell Boulevard on the west, which is a portion of Parcel # 02907000008 that comprises the

majority of the Liberty Park campus, and has a general address of 2477 Central Avenue as assigned by MLGW for planning purposes; and

Whereas, the City has completed the sitework and utility infrastructure in accordance with the planned development application approved by the Land Use Control Board and the Memphis City Council (Case # PD 19-18) and now has "build-ready" site pads available; and

Whereas, the administration and its team of advisors have selected Capstone Development, LLC for this hotel project ("Tenant"), based on the experience of the Group and its principals with hospitality development and their capacity to undertake this project and recommend that the City as "Landlord" execute an extended ground lease to Tenant while City maintains ownership of the land; and

Whereas, Tenant, using their private capital, would design, construct, own and operate a hotel of approximately 150 hotel rooms, including a restaurant and retail spaces on the ground floor and a rooftop bar, under a hotel flag and brand to be approved by the City, with said hotel to be located in the 1.25 acre lot labeled as "Parcel 1 - Hotel" on Attachment B (the "Property"); and

Whereas, Tenant would furthermore have a right of first refusal to submit a development proposal for a second hotel within the Master Development in the event that the City determines that additional hotel rooms are desirable; and

Whereas, if approved, the City would execute a ground lease for the Property with Tenant for an initial term of thirty (30) years with four (4) ten-year renewal options using a triple-net lease, meaning Tenant would be directly responsible for property taxes (as assessed after any PILOTs, reductions, or incentives which might be awarded by appropriate agencies), building insurance, and maintenance for the Property, in addition to rent and utilities; and

Whereas, the obligation to pay rent would commence on the date when the hotel first opens to the general public and the minimum rent shall be \$34,958.31 per year for the first five years, increasing by 4.0% every five years thereafter during both the base term and the exercised extension options, unless Tenant elects to prepay the rent for the initial term in advance; and

Whereas, Tenant would also be responsible for paying to the City the Property's pro-rata share of common area maintenance expenses or "CAM" for those common areas benefitting the Tenant or the general public and for which the City shall be responsible for the maintenance and repair, including but not limited to, parking lots, access and perimeter roads, truck passageways, loading platforms, landscaped areas, exterior walks, ramps, stairs, underground storm and sanitary sewers, utility lines, drinking fountains, and other public facilities, under a mutually acceptable agreement to be executed; and


Whereas, the Master Development will include additional retail, restaurant, entertainment and hospitality tenants, and the City as master developer and landlord shall be responsible for creating cross-easements, air rights leases, and/or vertical subdivisions as necessary to maximize enjoyment of use and value for all parties; and
