



HCD Celebrates FY25 Grant Awards Ceremony for Local Nonprofit Agencies

The Division of Housing and Community Development (HCD) recently hosted the FY25 grant awards ceremony, where funding was awarded to local nonprofit agencies. Funding from the U.S. Department of Housing and Urban Development (HUD) and the City of Memphis was provided via the HCD Strategic Community Investment Fund (SCIF).

SCIF, through its competitive funding process, enables the City to support a wide range of community-based projects, initiatives, and programs benefiting Memphis' neighborhoods and citizens. Nearly \$5.5 million has been awarded to local agencies to implement housing and community development initiatives during FY25 (July 1, 2024 - June 30, 2025).

The FY25 grant awards include the following:

- Emergency Solutions Grant (ESG)
- Housing Opportunities for Persons with AIDS/HIV (HOPWA)
- HOME-Funded Tenant-Based Rental Assistance (HOME-TBRA)
- Neighborhood Partnership Grant (NPG)

Thirteen (13) agencies have received awards from federally funded programs: ESG, HOPWA, and HOME-TBRA. Twenty-one (21) agencies have received awards from the City-funded NPG. The list of awarded agencies is provided below.
