- » Incorporated in 1987; opened doors in 1992
- » 501c(3) organization since 1987
- » Multi-agency Shelby County Child Protective Investigation Team (CPIT) headquartered at the Memphis CAC (law enforcement, child protective services, District Attorney's Office, Le Bonheur, other agencies)
- » Highly engaged Board of Directors
- » All services are free to victimized children and their supportive family members

Program Objectives

- » Mission: To serve children who are victims of sexual and severe physical abuse through prevention education and intervention.
- Problem Statement: Without intervention, child abuse increases rates of addiction, learning/school problems, mental health disorders, chronic medical issues, criminal behavior, and underemployment. Child sexual abuse is twice the national rate (Shelby County ACES study). Reported child abuse in Shelby County: 9,623 out of 66,497 in TN (2023 Annie E. Casey, KIDS COUNT).

» Goals:

- Facilitate a multi-agency, coordinated response to reported child abuse
- receive services from
- multiple agencies
- Connect families to critical community services to maximize positive outcomes
- Support the best possible outcomes for victimized children
- Train parents and adults who work with children how to recognize, respond to, and
- prevent child sexual abuse
